Terms and Conditions

Naveya & Sloane (the Promoter) Terms and Conditions of Promotion or Competition

1. By entering the competition each entrant will be deemed to have accepted these terms and conditions and to have agreed to be bound by them
2. The Promotion is only open to “Eligible Entrants”, being individuals who: (i) are residents of New Zealand, or (ii) are residents of Australia and will fly to a New Zealand domestic airport at their own expense, and (iii) are not employees or agents of the Promoter or any of its related corporations or any agencies associated with the Promotion
3. To enter the prize draw Eligible Entrants must make a qualified purchase by paying a minimum of 50% deposit for any *Naveya & Sloane* engagement ring with a minimum value of from \$5,000 including GST between 12 July - 10 September 2022
